5. Carriage of trees/logs shall not be carried out after the sun set and before the sunrise and permission, if any, would be arranged by the bidder him/herself.
6. The bidding form will be provided on the date of bidding itself which has to be filled up by the bidder. The bidder are advised to carry with them one photocopy of Identity Proof (PAN Card/Voter card/Aadhar Card/Ration Card/Driving Licence) to be submitted along with the bidding proforma.
