- 2. The tender documents shall be downloaded from e-tendering website www.tenderwizard.com/ISRO. Downloading of tender documents alone will not make a tenderer eligible for participating in the bidding. The documents uploaded by the tenderers will be subjected to verification subsequently by Department. If found not meeting the requirement, such offers will be rejected.
- 3. (a)Tenders should be accompanied with valid Earnest Money Deposit for value specified in Para 1 above, in the form of Deposit at Call receipt/ Term Deposit Receipt / Demand Draft of any Scheduled Bank issued in favour of "Director NESAC, Umiam, Meghalaya" payable at SBI Barapani (or) in the form of Bank guarantee issued by a scheduled bank. Earnest Money Deposit shall be valid for 180 days from the due date of receipt of tenders. In case EMD in the form of DD is furnished, the same will be encashed immediately on opening of tenders and refund of EMD for unsuccessful tenderers will be made through cheque/ electronically by the Department.
  - (b) The MSE units claiming exemption of Tender cost/ EMD should submit MSME UDYAM AADHAAR MEMORANDUM or registration certificate issued by District Industries Centre (DIC)/ Khadi&Village Industries Board (KVIB)/ Coir board/ National Small Industries Commission (NSIC)/ Directorate of Handicrafts and Handlooms or any other body specified by Ministry of MSME. The memorandum/ certificate shall be valid as on due date/ extended due date of the tender.
  - 4. Tenders will be opened at the Office of the Director, NESAC, Umiam, Meghalaya Pin-793103 on the stipulated date and time specified in Para 1 above.
  - (a) Original instrument of valid EMD shall be submitted to the Office of the Director, NESAC, Umiam, Meghalaya Pin-793103 on or before due date and time of opening of tender. If valid EMD is not received on or before due date and time of opening of tender, the tender offer shall be summarily rejected.

(b) The MSE units claiming exemption of Tender Cost/ EMD should submit attested hard copy of MSME UDYAM AADHAAR MEMORANDUM or registration certificate as indicated in para 4(b) above. The hard copy of above memorandum/ certificate shall be submitted to the **Office of the Director**, **NESAC**, **Umiam**, **Meghalaya Pin-793103** on or before due date and time of opening of tender. If hard copy is not received on or before due date and time of opening of tender, the tender offer shall be summarily rejected.

#### 6. Sequence of Bid Opening/ Evaluation:

- (a) On the due date of opening, the Techno-commercial bid of those tenderers who furnished valid EMD as per Para 4 above will **only** be opened.
- (b) On opening of Techno-commercial bid, further detailed scrutiny/ evaluation will be carried out in following stages:
  - Stage-I:Document Verification The documents furnished by the tenderers along with the Techno-commercial bid will be scrutinized by CMD and reviewed in detail by a Technical Evaluation Committee (TEC) of NESAC. Any tender found as not fulfilling the eligibility criteria as mentioned in Para 2 above will be rejected at this stage and such offers will not be considered for further processing.
  - **Stage II: Technical Evaluation -** The competency of the tenderers will be further evaluated by TEC, including inspection of selected works carried out by tenderers, as per guidelines indicated in the Tender evaluation format. The Technical Evaluation format including the evaluation traits is enclosed in the tender document.

**Note:** Any particular tenderer who has been technically evaluated by any of the DOS/ISRO Centres/ Units/ABs in the past <u>one year</u> for any work of similar nature and magnitude and for same criteria of evaluation, such bidders will not be re-evaluated and the scores of the previous evaluation will be taken for the assessment of the eligibility for the present tender.

- (c). The price bid of only those tenderers who have been qualified during the scrutiny and technical evaluation in Stage I and II will be opened separately on a specified date (with due intimation to the qualified bidders) and further processed, as per tender procedure/ stipulations.
- 7. The contractor, whose offer is accepted, will be required to furnish performance guarantee of 5% (Five Percent) of the tendered amount within 15 days from the date of issue of letter of intent/ work order. This guarantee shall be in the form of Deposit at Call receipt/Term Deposit Receipt of any Scheduled Bank issued in favour of "Director, NESAC, Umiam, Meghalaya Pin-793103" (or) in the form of Bank guarantee issued by a scheduled bank in accordance with the prescribed form. In case the contractor fails to deposit the said performance guarantee within the period specified including the extended period if any, the Earnest Money deposited by the contractor will be forfeited and letter of intent/ work order cancelled automatically without any notice to the contractor. The Earnest Money deposited along with tender shall be refunded only after receiving the aforesaid performance guarantee.
- 8. Intending tenderers may inspect the site before submitting the tenders, with the prior permission Director, NESAC.
- 9. The tender accepting authority is not bound to accept the lowest or any other tender and reserves the authority to reject any or all the tenders received without assigning any reason. All tenders in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the tenderer shall be summarily rejected.
- 10. The tender accepting authority also reserves the right to alter the scope/ or reduce quantum of work before issue of work order and the tenderer shall not have any claim what so ever on this account.

- 11. The tender accepting authority reserves the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.
- 12. Canvassing directly or indirectly, in connection with tender is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable for rejection.
- 13. The contractor shall not be permitted to tender for works in the Division of that particular Centre of the Department responsible for award and execution of contracts for which his/her near relative is working. He/she shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any Gazetted Officer in the Department of Space. Any breach of this condition by the contractor would render him liable for rejection of tender or cancellation of contract.
- 14. The tender should be valid for minimum period of 120 days from the due date of receipt of the tender specified in Para 1 above. If any tenderer withdraws the offer within the validity period or makes any modifications in the terms and conditions of the tender which are not acceptable to the Department, the Government shall without prejudice to any other right or remedy, be at liberty to forfeit 50% (Fifty Percent) of the Earnest Money Deposit absolutely. Further, the tenderer shall not be allowed to participate in the re-tendering process of the work.
- 15. On concluding the tender, an agreement shall be drawn with the successful tenderer.
- 16. The rates quoted shall include all taxes including Goods and Services Tax (GST) at applicable rates and levies, duties, cess etc., payable under respective statutes. Deductions as per statutes will be affected from the bill and remitted to the Department concerned.
- 17. In case of any discrepancies between Hindi & English version, English version shall prevail.
- 18. The said work is to be taken up inside NESAC Office Campus which is under CISF control. Therefore, following points are to be noted:-
  - (a) List of Staff and labour along with ID proof are to be submitted before commencement of work.
  - (b) Construction working hour from 0900 hrs to 17.00hrs. Beyond the said timing separate permission are to be accorded in advance from the competent authority with valid reason. Since the works are to be taken up inside NESAC Office Campus approach area/parking area in front of the gate are to be kept free from any obstruction/debris/dust etc. for smooth and easy movement.
  - (c)The workers will not be allowed to stay at site.
